#### Is your oregano fake?

A snapshot investigation into food fraud finds that a quarter of the dried oregano samples it examined contained other ingredients

A cutting-edge food fraud study – revealed exclusively to Which? – found that 25% of 78 samples of dried oregano bought from a range of retailers contained ingredients other than oregano. These ingredients, most commonly olive and myrtie leaves, were found to make up between 30% and 70% of the product – so in some cases, less than a third was actually oregano.

The snapshot investigation used oregano samples bought from a range of shops in the UK and Ireland and from online retailers. The test, using mass spectrometry which identifies compounds by their atomic composition, was conducted by Professor Ellot, Director of the institute for Global Food Security, and author of the independent review into food crime commissioned by the government in the wake of the horsemeat scandal.

We've teamed up with Professor Elliot in the past to reveal that 40% of the lamb takeaways we tested contained other meat and, on the back of this, launched our Food Fraud campaign.

We think it's unacceptable that you don't know what you are adding to your food. Which? chief food policy adviser, Sue Davis, said: 'This research suggests that food fraud remains rife. It highlights that retailers, producers and ultimately enforcement officers need to increase the checks in place across their herb supply chains to make sure that consumers are getting what they are paying for.'

We are sharing the results from this study with the Food Standards Agency (FSA).







